Minutes from Previous Meeting(s): Feb 10, 2020 Regular Meeting - Questions/Clarification/Corrections Motion to approve as written by Mayor Peeler, Second by Trustee Dumar with all in favor

Mayor's Report: Discussed current grants and the Montgomery Terrace project that is included, Stated that the sidewalk there will be damaged during the construction, Discussed the possibility of removing entire sidewalk from street, Surveys were sent to property owners on Montgomery Terrace asking their opinion of sidewalk removal

Public Comment: Residents/representatives of property owners on Montgomery Terrace asked questions; Keith Wheeler asked what will be done about the set of stairs at his property if sidewalk is removed; Karen Simpson, representing her brother Richard Deckro, asked why the work was being done, Mayor Peeler stated that work was going to be done on the sanitary sewer lines and also the storm sewers, Ms. Simpson asked why, Mayor Peeler responded that we need to combat Inflow and Infiltration (I&I), surface water is entering the sanitary sewer lines because they are in poor condition and entering the sewer plant which is then being unnecessarily treated, Have been working on I&I throughout the village the past 4 years, Regarding the stairs, each homeowner will be involved in deciding what will be done at their property. Some possibilities are to remove stairs, fill-in and seed, poor concrete wall and put up railing; Ms. Simpson stated that most of the properties have a retaining wall but her brother's does not, asked if one would be put in or what will happen if ground starts falling, Street & Water Commissioner replied that it would have to be look at after the construction, could put in riprap (stones), grass seed or vine plants; Ms. Simpson asked if the village will compensate for the property taken. Mayor Peeler responded that the work is being done in the village right of way and no property is being taken; Ms. Simpson then asked where it goes from here, what will happen next, Mayor Peeler stated the Board will discuss, wanted to hear from the property owners, will also discuss with the construction company, Street & Water Commissioner will discuss with each property owner and what they would like to happen. Village will send letter with updates: Keith Wheeler asked if there would be any assistance if he wanted to pour new steps, Mayor Peeler stated the village has a sidewalk program that could possibly work with that, suggested to get his name on the list if he was interested.

Karen Simpson and Jan Steele left at this point

Mayor Report (cont.): GAVAC contract needs to be renewed, current rent \$600/month, Board has mentioned raising to \$700/month, also discussed length of contract; Suggestion made in lieu of increasing the rent ask them to replace the 2 garage doors on the front of old fire department garage; Received approximate price of \$3,600 for 2 doors and \$1,200 for the openers; Suggestion made for a 5 year contract with rent of \$700/month for year 1 & 2, \$750 for year 3 & 4 and \$775 for year 5.

Motion by Mayor Peeler, Second by Trustee Dumar with all in favor, for the Mayor to make an offer to GAVAC of a five year contract with rent increased to \$700/month for year 1 & 2, \$750 for year 3 & 4 and \$775 for year 5 or in lieu of raising rent they purchase 2 new garage doors and openers on front of old fire department garage.

Mayor Report (cont.): Contractors that will be doing work on the sanitary sewer project approached the Mayor about using his personal property on Kane Rd to store their equipment, Mayor agreed and said there would be no fee, would have to make their own access to the property and leave property in same condition they found it in; Received a complaint about dogs on Upper Prospect St killing chickens, Also complaints about high speed traffic on N. Center St, Mr. Wheeler commented that they are speeding on Upper Prospect St as well, Mayor has sent an email to the Sheriff's department asking for patrols of the area; Looking at painting crosswalks in the village with white and yellow paint.

Public Comment: Sal Riggi commented that there needs to be a new committee member for the Park Committee since Wally Boyd has retired, Mayor Peeler stated that Trustee Flander has been appointed; Mr. Riggi made a suggestion that during the parking season the people handling money for parking wear gloves, Trustee Healey stated he would add them to the equipment tub.

Mayor Report (cont.): Ordered 22 LED snowflake light pole decorations, Looking at ordering seasonal banners for light poles, approximately 18" x 26", would like 4 seasons for the banners; Town of Mohawk will be making a donation to the village for decorations; Spoke with Engineer Steve Smith about the eastern wall of municipal building and roof repair for estimates to be included in new fiscal year budget.
