Public: Letter from Haven of Hope and Quiri Engineering distributed to Board, Patricia & Ernest Brookings from Haven of Hope, asking for a variance from Article 3 Private Wastewater Disposal Section 5 "At such time as a public sewer becomes available to a property served by a private wastewater disposal system, as provided in Article 3, section 4, a direct connection shall be made to the public sewer within ninety (90) days in compliance with this local law, and any septic tanks, cesspools and similar private wastewater disposal facilities shall be cleaned of sludge and filled with suitable material", **Mayor Peeler** asked for good or a time table?, **Code Enforcer Waddle** stated the life of a septic system is 15-20 years, **Mrs. Brookings** stated the cost of the septic system is more than \$15,000, **Trustee Healey** asked if it was an option to use the existing line from the house, **Code Enforcer Waddle** stated Street & Water Commissioner Weaver had concerns about added usage in that line, **Code Enforcer Waddle** stated that there had been a change in the plans to 100 gallons a day instead of 200 gallons per day since the letter was written.

Resolution #9-2022 Resolution Amending Sanitary Rule – Haven of Hope

Offered by William Peeler, Mayor, Seconded by Timothy Healey, Trustee

Whereas feasible sanitary services are not available to property 19 Cemetery Street, Fonda, NY;

Whereas representatives of the Haven of Hope have requested a variance to Article 3 Section 5 of the Village of Fonda Local Law which requires a property owner to convert to public sanitary services within 90 days of the availability to public sanitary services;

Whereas the cost of placing a septic system temporarily is costly to the property owner, the Board feels it unfair to the property owners and a burdensome cost if the owner would then have to switch to the Village Sanitary System in a short term;

Whereas the life expectancy of a septic system is 15 years or more and it is likely public sanitary services will become available in the near future.

Now, therefore let it be resolved, Board of Trustees authorizes exception to Article 3 Section 5 of the Village of Fonda Local requiring connection to public sanitary services within 90 days of availability to

the Haven of Hope located at 19 Cemetery Street, Village of Fonda, Town of Mohawk, Montgomery County, NY;

Be it further resolved, If Village Sanitary Services are readily made available within 15 years, the current property owner may continue using the private septic system up to 15 years, making the expiration of this exemption April 11, 2037.

Should Public Sanitary Service be available, and the private septic system should fail requiring replacement - the property owner will not be allowed to replace the private septic and will be required to connect to the public system;

This variance or exception does not extend to anyone should the current property transfer or sell the property located at 19 Cemetery Street, Fonda, New York, in whole or part.
