The permitted Biochemical Oxygen Demand (BOD) and Total Suspended Solids (TSS) removal target rates are 85%, set per NYS SPEDES Permit# NY003243. The monthly and year-to-date testing results are represented in the table below:

Chief Cotter reports that we had three instances of diesel contamination last month. NYSDEC requested the Village of Fultonville have a vendor run cameras down the main sewer trunk line on Riverside Dr. to search for the connections from the Travel Center. The same request is being made of the Travel Center to locate the laterals on their property.

The bolts on the west effluent tank's sluice gate valve broke. With the assistance of Fultonville DPW, the operators were able to find a temporary solution to the open the valve to continue operations. Chairman Park will reach out to Stephen Miller General Construction for an updated quote for the repair.

The road to the facility is in desperate need for repairs. Chairman Park to reach out to the Fair Board for discussion.
