The permitted Biochemical Oxygen Demand (BOD) and Total Suspended Solids (TSS) removal target rates are 85%, set per NYS SPEDES Permit# NY003243. The monthly and year-to-date testing results are represented in the table below:

Chief Cotter reported that a high flow event caused an overload on our wet well pumps shut down one of our two working pumps, which forced us to rent a pump, under emergency, to assist with the operations until we can get the pump back on-line. JM Electric is scheduled to visit the facility to perform a diagnosis of the circuitry.

Awaiting finalization of the wet well pump by Xylem. Once delivered JM Electric will be scheduled to complete the electrical hookup.

Upcoming purchases: Support chains and shackles for the wet well pump. Lawn Mower blades and tune up kit.
