### **Operational Considerations:**

**Operational Status Report.** (See attached)

The permitted Biochemical Oxygen Demand (BOD) and Total Suspended Solids (TSS) removal target rates are 85%, set per NYS SPEDES Permit# NY003243. The monthly and year-to-date testing results are represented in the table below:

#### Finances:

Discussion was had with John Mancini, Beacon Insurance, regarding adding on Officers and Directors Insurance to our current policies on July 7, 2022. #### **Open Forum:**

Frontier Phone Line – We have experienced several outgoing 911 calls, with Montgomery County Sheriff's Office being dispatched, in addition to static on the line. Reached out to Frontier for investigation. Frontier found a damaged underground line 40 feet east of the track wall on the entrance road. Frontier is planning to dig up to repair the line.

Trackside Road Paving – Per Montgomery County Fair Board, the cost of materials rose to high for them to consider for this budget year. They will revisit the estimate of costs in the spring and inform us of their findings.

ADA Accessibility – Stan Waddle, Village of Fonda Codes, visited the facility and measured the trackside entrance for the possibility of adding an ADA Accessible ramp on that entrance. See Report. Building Maintenance – Chief Cotter reported that the facility has a need for several repairs. He will submit a list for the board to prioritize.

Town of Glen collection system – Town of Glen is experience collection system backup issues on Riverside Dr prior to the Riverside Drive Pump Station. Doug Cole, Prime Engineering, is investigating on their behalf. Doug has hired a vendor to perform a cleanout. The vendor will be transporting the will be delivering the material here to the plant for disposal once complete.

Village of Fonda collection system – The facility experienced an inflow of petroleum over the weekends of August 21<sup>st</sup> and August 28<sup>th</sup>. NYSDEC Spills was contacted, and an investigation began including staff from NYS DEC, Chief Cotter and the Fonda DPW. It was determined that the inflow was coming from the West End of the Village's collection system, however due to an obstruction in the manhole located at the corner of Rt334 and Main St it could not be traced from there. Fonda DPW will clear the obstruction so the investigation can continue.

Village of Fultonville collection system – The engineering firm spearheading TCA's cleanup efforts has completed the task of disconnecting their lateral from the villages main sewer line. NYSDEC has recommended that the Village of Fultonville continue moving forward with permanently sealing that connection to prevent any further inflow that could possibly occur due to the damage in the line that was noticed during the camera inspection. Fultonville has contacted with Adirondack Septic to complete.

Annual Financial Report (AFR) – Leanne is in contact with the NYS Comptroller's Office to begin filing our Annual Financial Report.
