Questions/Clarification/Corrections.

Motion to approve as written by Mayor Peeler, Second by Trustee Healey with all in favor.

Public – Joe Smith, Adirondack Float Dock Shop. Mr. Smith explained that his company produces roto welded plastic docks. Said docks are durable and strong. Mr. Smith said he had reviewed the needs of the Village of Fonda Waterfront Project and believes such a dock would be the best option.

Chuck Marshall, Stewart's. Mr. Marshall explained the building project envisioned by Stewart's for the Fonda store. Mr. Marshall stated the project was adding a 16' addition on the western side and purchasing a house and garage, both of which will be demolished.

Chris Bailey (via Phone), CMCC Holdings, LLC. Mr. Bailey asked the Board for permission to add 2 additional trailers to his property. One would be on the corner of W. Prospect St and Putman Ave and the second would be on the corner of Cayadutta St and Wemple Ave.

Steve Hemlin, candidate for District 4 County Legislature. Mr. Hemlin asked for community support for his campaign. He stated his primary goals were to highlight local issues at the County level and to establish reliable telecommunications in the County.

William VanGorder, NBT Insurance Agency. Mr. Van Gorder reviewed the renewal policy. Citing the various components of the policy. Mr. Van Gorder noted that the current policy cost was \$24,623.44, and the renewal policy cost would be \$25,794.83. However, Mr. Van Gorder noted that the renewal policy does not include coverage for Cyber Liability due to the fact that some data needs to be supplied by the Village of Fonda such as "Fire Wall", automatic renewal of protections, and Cyber Protection Training.

Mayor Report -

Mayor spoke to the need to clarify a Motion made at the September Board Meeting regarding the use of 2nd ARPA monies.

Motion: by Mayor Peeler, seconded by Trustee Healey with all in favor to use 2nd payment of \$38,563.98 of American Rescue Plan Act to cover the Engineering Services by Prime AE regarding the Village of Fonda Reservoir Dam safety inspection and engineering assessment in the amount of \$25,600.00. The remaining amount of \$12,963.98 to be used towards the purchase of water meters and/or MIU's.

Mayor spoke to the recent water main break within the Village. Mayor Peeler noted that said break was only the second this year. He further stated that the Village must by law issue boil water advisories to protect the safety and health of the residents. Said boil water advisory can only be lifted after testing so permits

Mayor spoke concerning the boat launch project. Said project as designed will require 290' of fiberglass dock with an anticipated cost between \$100,000.00 and \$150,000.00.

Mayor spoke concerning the school sidewalk project. Mayor met with the school, Montgomery County and the Town of Mohawk. Plan would be to use an existing roadway into the Cemetery. Entry would be 8' wide and blacktopped. Project will not begin before the end of the school year.

Mayor spoke concerning the Flood Mitigation and Broadway Creek & Letter to Town of Mohawk. Said meeting and letter discussed Phase 2 & 3 of Flood Mitigation and an estimated cost of over \$40,000.00. Also discussed was the cost of meters and MIU's to Town of Mohawk residents at \$39,200.00.

Mayor Peeler left the meeting at 8:08 pm Deputy Mayor Healey assumed oversight of the Meeting.

Street & Water Commissioner Report: Written and submitted. No questions from the Board

Mayor Peeler returned at 8:15 pm to re-assume oversight of the meeting.

One trailer will be located on the corner of West Prospect Street and Putnam Ave. The second trailer would be located on the corner of Cayadutta St and Wemple Ave.
