He shall not directly or indirectly solicit any gifts or accept or receive any gift having a value of \$75 or more, whether in the form of money, services, loan, travel, entertainment, hospitality, thing or promise, or any other form, under circumstances in which it could reasonably be inferred that the gift was intended to influence him, or could reasonably be expected to influence him, in the performance of his official duties or was intended as a reward for any official action on his part."

NOW THEREFOR BE IT RESOLVED that, the Employee Handbook be updated to change the dollar value regarding gifts to \$75.00.
