RESOLUTION #6-2026 RESOLUTION AUTHORIZING OFFICIAL SIGNATORIES FOR NBT BANK ACCOUNTS

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Fonda hereby authorizes the following individuals as official signatories for all applicable Village of Fonda accounts held with NBT Bank:

- Shaun Schriner, Trustee
- Mark Scott, Trustee
- Christine Kearns, Village Clerk

BE IT FURTHER RESOLVED, that the Mayor is authorized to designate which of the above officials may act as signatories in the Mayor’s absence or as operational needs require, consistent with bank policy and internal controls;

BE IT FURTHER RESOLVED, that this authorization shall become effective immediately upon approval by the Board of Trustees and upon completion and submission of all documentation required by NBT Bank;

BE IT FURTHER RESOLVED, that the Village Clerk is directed to provide certified copies of this resolution and any required supporting documentation to NBT Bank to implement these authorizations.

RESOLUTION # 7-2026 RESOLUTION AUTHORIZING PAYROLL CERTIFICATION OFFICIALS

BE IT FURTHER RESOLVED, that such certification authority shall apply in the absence of the Mayor or Deputy Mayor, or when operational necessity requires timely payroll processing;

BE IT FURTHER RESOLVED, that this authorization shall take effect immediately upon approval by the Board of Trustees;

BE IT FURTHER RESOLVED, that the Village Clerk is directed to maintain this resolution on file and provide certified copies as required for payroll processing and audit purposes.
