

INVITATION TO BID FOR THE COLLECTION AND REMOVAL OF GARBAGE, TRASH, AND RECYCLABLE MATERIALS Bid #25-01

Submission Deadline: March 7, 2025, by 3:00 PM

Contract Period: Five years, beginning June 1, 2025

The Village of Fonda will receive sealed bids for the collection and removal of garbage, trash, and recyclable materials until 3:00 PM on Friday, March 7, 2025, at the Office of the Village Clerk, located at 8 E. Main Street, PO Box 447, Fonda, NY 12068. Bids will be publicly opened and read at the regular monthly board meeting at 6:30 PM on Monday, March 10, 2025.

Form of Submission

- All bids shall be submitted in a sealed, opaque envelope clearly marked:
 "Bid for the Collection and Removal of Garbage, Trash, and Recyclable Materials Bid #25-01."
- Bids must be submitted using the forms provided by the Village of Fonda and filled out completely. Any item with no bid should be marked "No Bid."
- Bids must be executed by the bidder or an authorized representative of a corporation or partnership. If a corporation, the corporate seal must be affixed where indicated.
- Bidders must submit a properly executed Non-Collusion Certificate with their bid.
- The Village of Fonda reserves the right to reject any or all bids, waive any irregularities, and award the bid to the lowest responsive and responsible bidder in the best interest of the Village.

Bid Validity Period

Bids may be withdrawn before opening. Once opened, they remain in effect for **forty-five (45) days** from the opening date.

Compliance with Laws and Regulations

The bidder is responsible for adhering to all applicable federal, state, and local laws and regulations governing the bid. **Appendix A – Standard Clauses for NYS Contracts** is incorporated into this bid document.

Tax Exemptions

The Village of Fonda is exempt from federal and state sales or use taxes. Bidders shall not include such taxes in their bid prices.

Indemnification

The contractor shall indemnify and hold the Village of Fonda harmless from any and all claims, actions, damages, liabilities, and charges arising from the contractor's operations, negligence, or fault during the course of work under this contract.

Insurance Requirements

The contractor shall procure and maintain the following insurance coverage:

- 1. Workers' Compensation and Employer's Liability Insurance for job-related injuries.
- 2. **Automobile Liability Insurance** limits of at least **\$1,000,000 per accident** for bodily injury, death, or property damage.
- 3. Public or General Liability Insurance with the following limits:

Each Occurrence: \$1,000,000

Aggregate: \$2,000,000

4. The Village of Fonda must be named as an **Additional Insured** on all applicable policies. A **Certificate of Insurance** must be provided before work commences, with a ten (10) day notification period for cancellations.

Assignment and Subcontracting

- The contractor shall not assign, transfer, sublet, or otherwise dispose of any part of the work without the Village's prior written consent.
- The contractor shall provide **60 days written notice** of any intent to assign, transfer, or sublet this contract.

Supervision of Work

- The contractor shall be responsible for all operations under this contract.
- The village shall be provided with a list of supervisory personnel and their contact numbers, including a **designated emergency point of contact**.

Contractor Qualifications

- The contractor must have successfully performed municipal garbage contracts for at least three (3) of the past ten (10) years.
- If the contractor does not meet this requirement, they must provide a **performance bond** equal to the first year's bid price.

Scope of Work - Waste Collection Services for the Village of Fonda

The Village of Fonda seeks a contractor to provide waste collection services for five years, from **June 1, 2025, to May 31, 2030**. The selected contractor shall be responsible for collecting, removing, and disposing **of all garbage, trash, and recyclable materials** within the corporate boundaries of the village.

Service Requirements:

The contractor shall:

- Collect waste once weekly from all residences and small commercial businesses, as Chapter 138 of the Village Code outlines.
- Provide service for two (2) 64-gallon containers per taxed parcel.
- Offer additional container services at a contractor-established rate, payable directly by property owners.
- Ensure large commercial businesses and tax-exempt properties contract separately for waste collection.
- Utilize leak-proof, enclosed metal garbage trucks and compartmentalized recycling trucks for collection.
- Ensure all drivers hold a valid New York State Commercial Driver's License (CDL).
- Clean up any spilled waste and return refuse containers upright after collection.
- Notify the Village at least 30 days before any proposed changes to the collection schedule.

Billable Units and Collection Scope:

Total Parcels 2025: 294

Less commercial roll-offs: 22

Total Billable Units: 272

Each taxed parcel within the Village will receive one standard weekly collection service for up to two 64-gallon containers per unit. Multi-unit residential properties within a single-taxed parcel will be included in standard service. Commercial roll-off containers are excluded from this contract and must be arranged separately by the business owner.

The selected contractor must provide **reliable and efficient** waste collection services and ensure **compliance with all local, state, and federal regulations**.

Spring and Fall Dumpster Services

The contractor shall provide the Village of Fonda with spring and fall dumpster services, delivering and removing the requested number of dumpsters each service period.

Specifications:

- The contractor shall deliver the requested quantity of 40-cubic-yard dumpsters to a designated location within the Village of Fonda for both spring and fall collection periods.
- Removal of the dumpster shall occur after each dumpster is filled, as determined by the Village.
- Tipping fees shall be paid separately by the Village of Fonda.
- The contractor's bid must include pricing for delivery and removal services per dumpster for the spring and fall periods.

Municipal Service Provision Clause

As part of this contract, the selected contractor shall provide the Village of Fonda Municipal Building, 8 E. Main Street, and the Waste Treatment Facility, 28 S. Bridge Street, with one commercial waste collection bin at each location at no cost for the duration of the agreement (June 1, 2025 – May 31, 2030). The bin shall be appropriate in size to accommodate the facility's waste needs and shall be collected regularly and according to commercial service standards.

The contractor shall ensure:

The bins are adequately maintained, clean, and in good working condition throughout the contract term.

- Waste collection is timely and does not disrupt municipal operations.
- The Village incurs no charges for the bin or its collection services.

This provision shall be a mandatory component of the bid proposal, and failure to comply may result in disqualification or contract termination.

Holiday and Weather-Related Adjustments

- The Village and the contractor must mutually agree on holiday collection schedules.
- In the event of severe weather, the contractor must complete missed collections on the next business day.

Contract Termination

The Village of Fonda reserves the right to terminate the contract if the contractor's certification under NYS Finance Law §139j and §139k is found to be intentionally false or incomplete.

APPENDIX A: STANDARD CLAUSES FOR NYS CONTRACTS

The parties to the attached contract, license, lease, amendment, or other agreement of any kind (hereinafter, "the contract" or "this contract") agree to be bound by the following clauses which are hereby made a part of the contract (the word "Contractor" herein refers to any party other than the State, whether a contractor, licenser, licensee, lessor, lessee, or any other party):

- 1. **EXECUTORY CLAUSE:** In accordance with Section 41 of the State Finance Law, the State shall have no liability under this contract to the Contractor or to anyone else beyond funds appropriated and available for this contract.
- NON-ASSIGNMENT CLAUSE: In accordance with Section 138 of the State Finance Law, this contract may not be
 assigned by the Contractor or its right, title, or interest therein assigned, transferred, conveyed, sublet, or otherwise
 disposed of without the previous consent, in writing, of the State. Any attempts to assign the contract without the
 State's written consent are null and void.
- COMPTROLLER'S APPROVAL: In accordance with Section 112 of the State Finance Law, this contract shall not be valid, effective, or binding upon the State until it has been approved by the State Comptroller and filed in their office, where applicable.
- 4. **WORKERS' COMPENSATION BENEFITS:** In accordance with Section 142 of the State Finance Law, this contract shall be void and of no force and effect unless the Contractor provides and maintains coverage during the life of this contract for the benefit of such employees as required by the Workers' Compensation Law.
- 5. **NON-DISCRIMINATION REQUIREMENTS:** The Contractor shall comply with all applicable federal and state laws prohibiting discrimination, including Article 15 of the Executive Law.
- 6. **WAGE AND HOURS PROVISIONS:** If this is a public work contract covered by Article 8 or 9 of the Labor Law, the Contractor must comply with prevailing wage and supplement requirements.
- 7. **NON-COLLUSIVE BIDDING CERTIFICATION:** In accordance with Section 139-D of the State Finance Law, the Contractor affirms, under penalty of perjury, that its bid was arrived at independently and without collusion aimed at restricting competition.
- 8. **INTERNATIONAL BOYCOTT PROHIBITION:** The Contractor agrees, as a material condition of the contract, that it has not participated and will not participate in an international boycott in violation of federal law.
- 9. **SET-OFF RIGHTS:** The State retains all statutory rights of set-off, including withholding payments due to the Contractor to satisfy any outstanding obligations.
- 10. **RECORDS:** The Contractor shall maintain complete and accurate books and records related to this contract, which must be retained for at least six years or as required by law.
- 11. **IDENTIFYING INFORMATION AND PRIVACY NOTIFICATION:** The Contractor must provide its Federal Employer Identification Number (FEIN) or Social Security Number on all invoices or payment vouchers.
- 12. **EQUAL EMPLOYMENT OPPORTUNITIES FOR MINORITIES AND WOMEN:** In accordance with Section 312 of the Executive Law, the Contractor will ensure equal employment opportunities.
- 13. **CONFLICTING TERMS:** In case of a conflict between this contract and Appendix A, the terms of Appendix A shall prevail.
- 14. GOVERNING LAW: This contract shall be governed by the laws of the State of New York.
- 15. LATE PAYMENT: Payment timelines shall be governed by Article 11-A of the State Finance Law.
- 16. NO ARBITRATION: Disputes shall be resolved in a court of competent jurisdiction in New York State.
- 17. **SERVICE OF PROCESS:** The Contractor consents to service of process upon it by registered or certified mail.
- 18. **PROHIBITION ON PURCHASE OF TROPICAL HARDWOODS:** The Contractor certifies compliance with State Finance Law Section 165 regarding the use of tropical hardwoods.
- 19. **MACBRIDE FAIR EMPLOYMENT PRINCIPLES:** The Contractor affirms compliance with the MacBride Fair Employment Principles regarding business operations in Northern Ireland.
- 20. **OMNIBUS PROCUREMENT ACT OF 1992:** The Contractor certifies efforts to encourage the participation of New York State business enterprises as suppliers and subcontractors.
- 21. **RECIPROCITY AND SANCTIONS PROVISIONS:** Contracts may be denied to bidders whose home states impose restrictions on New York State vendors.

- 22. COMPLIANCE WITH NEW YORK STATE INFORMATION SECURITY BREACH AND NOTIFICATION ACT: The Contractor shall comply with the provisions of the New York State Information Security Breach and Notification Act.
- 23. **COMPLIANCE WITH CONSULTANT DISCLOSURE LAW:** If this is a consulting contract, the Contractor must submit the required reports per State Finance Law.
- 24. **PROCUREMENT LOBBYING:** The contractor affirms compliance with State Finance Law Sections 139-j and 139-k regarding procurement lobbying disclosures.
- 25. **CERTIFICATION OF REGISTRATION TO COLLECT SALES TAX:** If required under Tax Law Section 5-a, failure to certify compliance may result in contract termination.
- 26. **IRAN DIVESTMENT ACT:** The Contractor certifies that it is not on the prohibited entities list under State Finance Law Section 165-a regarding Iran divestment.
