Mayor Report – Prime AE reached out regarding the water system improvements, some grant money left but not enough for work on Route 5, Route 334, Railroad St., and Park St., estimate 1.38 miles of water line at a cost of \$2.34 million, current water rate in the village is \$2.72/thousand gallons for the first 20,000 gallons, current minimum water bill is \$109.40 would increase to \$260.01 for improvements, Mayor asked the board for their opinions, Trustee Healey - get enough money to get it all done, Trustee Dumar – prices continue to go up, Trustee Klim agreed with Trustee Dumar, Trustee Sprague asked what kind of piping was used for estimate, Street & Water Commissioner Weaver didn't know.

Motion by Mayor Peeler, Seconded by Trustee Klim with all in favor to approve the Mayor to sign the necessary paperwork to move forward with extending the EFC water bond to complete additional waterline work.

Resolution #31-2024 Authorization for Statutory Bond for the Purchase of a 2024 Pickup Truck Offered by Mayor Peeler, Seconded by Trustee Sprague

WHEREAS, the Village of Fonda has identified the need for a 2024 Pickup Truck for the Department of Public Works, including a stainless-steel v-plow to maintain operational efficiency and safety during snow removal and other municipal services and

WHEREAS, the total estimated cost for the acquisition of said vehicle, v-plow, and associated fees is \$56,994.00, broken down as follows:

- 1. Vehicle Cost: \$46,847.30
- 2. Stainless Steel V-Plow: \$9,950.00
- 3. **Tire Fee**: \$12.50

- 4. NYS Inspection Fee: \$10.00
- 5. Registration and Administrative Fees: \$175.00

WHEREAS, it is determined that the period of probable usefulness (PPU) for the vehicle is appropriate for a four (4) year bond under Section 11.00 of the Local Finance Law;

WHEREAS, the Village of Fonda desires to finance this purchase through the issuance of a Bond or Bond Anticipation Note (BAN) with NBT Bank;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF FONDA as follows:

Section 1: Purpose and Authorization

The Board of Trustees authorizes the purchase of the 2024 Pickup Truck, including the stainless-steel v-plow and all related fees, as outlined above.

Section 2: Financing Plan

The total estimated cost of \$56,994.00 shall be financed through a Statutory Bond to be repaid over four (4) years in annual installments, as permitted by the Local Finance Law.

Section 3: Delegation of Authority

The Village Mayor, William Peeler, is authorized to sign all necessary documents to secure the financing with NBT Bank. The Village Clerk, Christine Kearns, shall ensure the filing and publication of all required notices.

Section 4: Full Faith and Credit

The full faith and credit of the Village of Fonda are irrevocably pledged for the payment of the principal and interest on the Statutory Bond or note. An annual appropriation shall be made sufficient to pay such debt service.

Section 5: Estoppel and Publication

This resolution shall take effect immediately upon adoption. The Village Clerk is directed to publish a Notice of Estoppel in the official newspaper, stating that the validity of the obligations authorized by this resolution may only be contested under specific conditions within twenty (20) days of publication.
